The system is easy to use and completes the process in SECONDS. Additionally, the system generates an electronic audit trail of all activity that can be printed, emailed or stored for later retrieval for management or investigative reports. Given its ability to also produce employee identification badges, **FAST-PASS®** is the ideal choice for replacement of existing badging systems that do not offer its wide array of security features.

VISITOR REGISTRATION

- Captures current photo of visitor
- Automated data entry from driver's license, government ID's and passports

- Simple point and click operation for ease of use

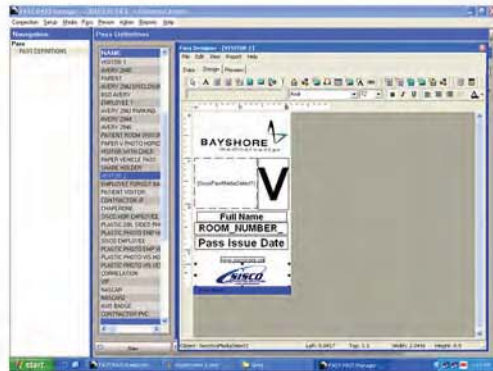


AUTOMATED WATCH LIST & DENY ENTRY
